## A BILL

To amend the Public Health Service Act to extend funding for the National Health Service Corps program.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “National Health Serv-  
5 ice Corps Strengthening Act of 2017”.

6 **SEC. 2. FINDINGS.**

7 The Congress finds as follows:

8 (1) The National Health Service Corps (NHSC)  
9 program provides scholarships and loan repayment

1 for primary care providers serving in designated  
2 shortage areas of the country.

3 (2) The NHSC program has proven to be an ef-  
4 fective and cost-efficient program that enables pro-  
5 viders to both choose primary care practice and  
6 serve in a shortage area of the country.

7 (3) Since its founding 45 years ago, more than  
8 50,000 providers have participated in the NHSC  
9 program.

10 (4) Today, more than 11 million people receive  
11 access to primary medical, dental, and mental health  
12 services from a NHSC provider.

13 (5) However, more than 66 million people live  
14 in designated primary care shortage areas of the  
15 country. Additionally, more than 51 million live in  
16 dental health shortage areas, and more than 106  
17 million live in mental and behavioral health shortage  
18 areas.

19 (6) A modest expansion of the NHSC through  
20 2022 would enable nearly 5 million additional people  
21 to receive primary care through a NHSC-supported  
22 provider.

23 (7) A 5-year extension of the funding for the  
24 NHSC is critical to preserve access to care for mil-  
25 lions of underserved people.

1           (8) For these reasons, it is vital to extend and  
2           strengthen the NHSC program for fiscal year 2018  
3           and beyond.

4 **SEC. 3. EXTENSION OF FUNDING FOR THE NATIONAL**  
5 **HEALTH SERVICE CORPS PROGRAM.**

6           Paragraph (2) of section 10503(b) of the Patient  
7           Protection and Affordable Care Act (42 U.S.C. 254b–  
8           2(b)) is amended—

9           (1) in subparagraph (D), by striking “and” at  
10          the end; and

11          (2) in subparagraph (E), by striking the period  
12          at the end and inserting “; and”; and

13          (3) by adding at the end the following:

14                 “(F) \$320,000,000 for fiscal year 2018;

15                 “(G) \$330,000,000 for fiscal year 2019;

16                 “(H) \$340,000,000 for fiscal year 2020;

17                 “(I) \$350,000,000 for fiscal year 2021;

18                 and

19                 “(J) \$360,000,000 for fiscal year 2022.”.
